

Consent to the processing of personal data

1. General terms and conditions of personal data processing

1.1 This consent to the processing of personal data (hereinafter referred to as "Consent") is a document defining the policy of the operator of personal data, and contains information about the requirements for their protection in accordance with the Federal Law "On Information, Information Technologies and Information Protection" dated 27.07.2006 N 149-FZ (FL no. 149)

1.2 The operator of personal data is the limited liability company "LTD CHIPSA DESIGN", IN: 402206741, location address Georgia, Tbilisi, A. Tsereteli 56 tel. +995568921544 (hereinafter referred to as the "Operator")

1.3 Personal data in this Consent means information related directly or indirectly to an individual – the subject of personal data.

1.4 The subject of personal data is a capable adult who has provided his personal data to the Operator. (hereinafter referred to as "User")

2. Principles of personal data collection and processing

2.1 The user, making an application on the website <http://chipsa.ru/> (hereinafter referred to as the Site),

agrees to the terms of this Consent to the processing of personal data in accordance with Article 9 of Federal Law no. 152 from 27.07.2006 "On Personal Data".

Acceptance of the Consent offer is sending an application from the Site.

2.2 The User gives his consent to the Operator to process his personal data with the following conditions:

2.2.1 This Consent is given to the processing of personal data both without and with the use of automation tools.

2.2.2 Consent applies to the following information:

last name, first name, patronymic, phone, email.

2.2.3 Consent to the processing of personal data is given in order to provide the User with:

- response to the request;
- further conclusion and fulfillment of obligations under contracts;
- implementation of customer support;
- informing about services that, in the opinion of the Operator, may be of interest to the subject of personal data,
- conducting surveys and marketing research.



2.2.4 The User grants the Operator the right to perform the following actions (operations) with personal data: collection, recording, systematization, accumulation, storage, clarification (updating, modification), use, depersonalization, blocking, deletion and destruction, transfer to third parties, with the consent of the subject of personal data and compliance with measures ensuring the protection of personal data from unauthorized access.

2.2.5. Personal data is processed by the Operator until all necessary procedures are completed. The processing can also be terminated at the User's request by e-mail: info@chipsa.design.

2.2.6. The User confirms that by giving Consent, he acts freely, of his own free will and in his own interest.

2.2.7. This Consent is valid indefinitely until the termination of the processing of personal data for the reasons specified in clause 2.2.5 of this document.

3. Access to and protection of personal data

3.1 The Operator takes organizational and technical measures necessary and sufficient to protect the User's personal data from unauthorized or accidental access, destruction, modification, blocking, copying, distribution, as well as from other illegal actions of third parties in relation to such data.

3.2 Persons who are not employees and representatives of the Operator do not have access to the User's personal data, except for personal data that are made publicly available by the User, as well as cases provided for by this Consent or the law.

In particular, other Users may have access to the User's personal data transmitted by them to the Operator and published on Websites or in the Application.

3.3 The User's personal data is not transferred to third parties, except in cases stipulated by the provisions of the Policy or the Law.

4. Changing the Consent document

4.1. The Operator has the right to change this Consent at its discretion.

The new version of the Consent is posted on the Websites and comes into force from the date of its publication on the Website.
